

Manufacturer warranties each Banshee LiFePO4 Marine® - branded battery sold or any of its authorized distributors or dealers in the United States and Canada to be free of defects in material and workmanship for a period of 5 years with the 5th year being 50% prorated, after the date of purchase, as evidenced by the original receipt (the "Warranty Period").

NON-TRANSFERABLE

This warranty applies only to the original end-user / application owner of the product and is not transferable to any other person or entity.

NOT COVERED BY THIS WARRANTY:

Manufacturer has no obligation under this warranty with respect to any defects or damage to the battery arising from any abuse or mishandling of the battery ("Product"), including any one or more of the following:

- Failure to properly install the battery.
- Failure to properly store the battery. This includes not disconnecting battery/s from any items that may draw power.
- Damage due to over tightening and stripping the terminals.
- Not properly balancing series systems with use of automatic balancer or manual balancing.
- Product that was used for applications other than which it was designed and intended for.
- Misapplied or improperly sized battery for the application, for example too few Amp Hours for system.
- Incorrect voltage applied to application.
- Batteries that have had the manufacturing date codes destroyed or tampered with.
- Breakage, freezing, wreckage, water damage, melted and broken terminals.
- Damage caused during shipping or mishandling of the product.
- Damage due to improper installation; loose terminal connections, under-sized cabling, incorrect connections (series and parallel) for desired voltage and AH requirements, installing in reverse polarity.
- Environmental damage: inappropriate storage conditions as defined by the manufacturer; exposure to extreme hot or cold temperatures.
- Product that has been opened, modified or tampered with.
- Using Discharge/Test machines.

HOW TO MAKE A CLAIM:

Warranty claims are to be only to be made by the end-user / owner of the application.

All requests must start by contacting customer support by calling 815-467-6464

Customer support is trained to understand and resolve any issue before the need for a warranty replacement. If customer support deems it necessary to warranty the manufacturer will require the original battery back. The customer/owner of the product is responsible for shipping the product back. Every box must include a copy the original proof of purchase. If this is not included the item will be returned to sender.

Manufacturer will test the product and determine if the product was affected by the above defects or damage to the Battery arising from any abuse or mishandling of the battery ("Product"). See list of non-covered conditions located above.

Warranties are for repair, replacement, or substitution only, in the manufacture's sole discretion. Refunds are not available after 30 days.

The Product must be shipped in compliance with UN38.3. Please note that DOT requires all persons shipping batteries to be Hazmat certified.

WARRANTY DISCLAIMER:

This warranty is in lieu of, and manufacturer disclaims and excludes, all other express warranties. Manufacturer further limits the duration of all, whether statutory, express or implied warranties, including, without limitation, any warranty of merchantability or fitness for a particular purpose, to the warranty period.

Manufacturer's exclusive liability for breach of any warranty on the battery shall be to replace the battery within the warranty period in accordance with the terms of this warranty. In no event shall manufacturer be liable for any loss or damages of any other kind, whether direct, incidental, and consequential including lost profits, exemplary, special or otherwise, including any lost profits or removal, shipping, or installation expenses.

EXCEPT FOR THE WARRANTY SET FORTH ABOVE, SELLER MAKES NO WARRANTY WHATSOEVER WITH RESPECT TO THE GOODS, INCLUDING ANY (A) WARRANTY OF MERCHANTABILITY; OR (B) WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE; WHETHER EXPRESS OR IMPLIED BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OF TRADE OR OTHERWISE.
